#### Welcome & Introductions

### **Brian O. Martin, Executive Director MVRPC**

Representatives from Beavercreek, Greene County, Greene County Engineer, Harrison Township, Trotwood, City of Dayton, CityWide Development, Montgomery County, Montgomery County Engineer, Montgomery County Public Health, Montgomery County Land Bank, Five Rivers Metroparks, Union Township, Troy, Miami County, Long-Term Recovery Operations Group, St. Vincent DePaul and The Dayton Foundation were present for the meeting. Also in attendance were representatives from the offices of Governor DeWine, Representative Turner and Senator Portman as well as a journalist from the Dayton Daily News.

## Individual Recovery Update

## Laura Mercer, Disaster Recovery Manager

Case Management for individuals and families impacted by the disaster continues to be the focus, with more than 400 active cases throughout the Region. There are now 4 Disaster Case Managers on board with 6 more coming soon. Most individuals in case management were uninsured or underinsured.

The Disaster Recovery Operations Group is gearing up for a large scale rebuilding effort in Spring 2020.

Discussion of the need to convene all jurisdictions in early 2020 for a task group on permitting and inspection streamlining. MVRPC will lead this effort.

Disaster Recovery Operations Group meeting minutes were made available to anyone interested in details of the work this group is accomplishing to assist individuals with recovery.

#### **Community Fundraising Update**

#### **Jeanne Holihan, The Dayton Foundation**

Approximately \$1.8 million raised through The Dayton Foundation for Disaster Relief. The Dayton Foundation is using these funds to support both the individual and public jurisdiction sides of the community disaster network.

## Community Recovery Update Brian O. Martin & Stacy Schweikhart, MVRPC

We are awaiting final notification on our application to the EDA for a full-time Disaster Recovery Manager to assist all impacted jurisdictions in the region.

We are working with The Dayton Foundation and leaders of the Individual Recovery Network on the formation of a Disaster Recovery Leadership Advisory Board. Appointments to the Board will be made for approximately 20 Regional leaders representing various sectors invested in Disaster Recovery. We are in the early stages of this conversation and will have an update at the next meeting.

Any jurisdictions interested in having Stacy Schweikhart and Laura Mercer come out to meeting with your elected officials, staff or community members should contact Stacy to schedule. They have visited a few communities already and the meetings have been very helpful in connecting resources and making sure that both the jurisdiction and impacted members in the community make best use of the support available to them.
