The Miami Valley Regional Planning Commission Board of Directors met on May 5, 2022 at 9:00 a.m. at Dayton Realtors 1515 S. Main St., Dayton, Ohio 45402. All members and news media were notified of the meeting pursuant to the Sunshine Law.

I. INTRODUCTIONS

Chairperson Simmons called the meeting to order at 9:03 a.m. Self-introductions were made. The Pledge of Allegiance was recited.

II. APPROVAL OF APRIL 7, 2022 MEETING MINUTES

Mr. Berry made a motion to approve the minutes from the April 7, 2022 Board meeting. Ms. Lommatzsch seconded the motion. The motion passed unanimously.

III. PUBLIC COMMENT PERIOD ON ACTION ITEMS

None

IV. RPC (REGIONAL PLANNING COMMISSION) ACTION ITEMS

A. Recommended Adoption of the MVRPC Budget and Work Program SFY 2023

Mr. Lucas reviewed the draft Budget and Work program for SFY 2023. He provided an overview of the layout of the Work Program and explained the different funding sources by each work element. He then discussed Schedules A-G and provided a brief summary of each table. Mr. Lucas then referred to the Staffing Profile on Schedule C and stated they've added new positions and are actively hiring and recruiting.

Mr. Lucas also discussed how MVRPC is currently working with ODOT to create the Regional Planning Organization (RPO) for the rural jurisdictions of the Miami Valley region in Darke, Preble and Shelby Counties. Mr. Lucas then opened the floor for questions and addressed new members and membership dues. A Policy Subcommittee meeting is scheduled for May 17th to further discuss the new membership dues.

Mr. Bruns made the motion to approve the SFY 2023 Budget and Work Program. Mr. Serr seconded the motion. The motion passed unanimously.

B. Institute Steering Committee Recommendation for the 2022 Livable, Age-Friendly Communities Grants

Ms. Sempeles announced the MVRPC member organizations that have applied to receive a \$10,000 Livable, Age-Friendly Communities Grants from the DMH-Dayton Fund at The Dayton Foundation to become an AARP Livable, Age-Friendly Community. She explained the funds will be used for community surveys, data analysis and technical assistance for communities to begin Phase 1 of the AARP Livable, Age-Friendly Communities multi-year planning effort. She then referenced the summary of applicants and the age-related demographics for their communities in the packet. Lastly Ms. Sempeles stated that MVRPC Staff and the Institute for Livable and Equitable Communities Steering Committee recommends Board approval to recommend to The Dayton Foundation that funding be awarded to the MVRPC member communities.

Ms. Wallace made a motion to approve the resolution forwarding the 2022 Livable, Age-Friendly Communities Grants to The Dayton Foundation for funding. Mr. Graves seconded the motion. The motion passed unanimously.

C. Areawide Water Quality Management Plan Amendment

Mr. Lindsay provided an update on the Areawide Water Quality Management Plan. He stated on February 22, 2022 the Tri-Cities Wastewater Authority (Tri-Cities) provided a formal request to modify the boundaries of the Tri-Cities and Dayton Facility Planning Areas (FPA) within the Areawide Water Quality Management Plan. Mr. Lindsay then shared a map of the current FPAs. He explained the proposed boundary changes and stated in 2019 the cities of Dayton and Vandalia signed an agreement to swap areas within their respective FPA for purposes of planned development and shared a map showing the proposed FPA updates. Lastly, he shared MVRPC's review process timeline and stated MVRPC staff and the Technical Advisory Committee recommend Board approval of this FPA boundary change.

Ms. Lommatzsch motioned to approve the Areawide Water Quality Management Plan amendment. Mr. Joseph seconded the motion. The motion passed unanimously.

V. MPO (METROPOLITAN PLANNING ORGANIZATION) ACTION ITEMS

A. Recommended Adoption of Amendment #18 to MVRPC's SFY 2021-2024 Transportation Improvement Program (TIP)

Mr. Arnold referred to the 18th amendment to the SFY 2021-2024 TIP and the numerous project changes made by MVRPC and ODOT. He referred to the packet showing the tables broken down by county, as well as the statewide line item project tables. Mr. Arnold stated that MVRPC Staff and the Technical Advisory Committee recommend adoption of Amendment #18 to the SFY 2021-2024 Transportation Improvement Program.

Mr. Stroud made a motion to approve the resolution adopting Amendment #18 to MVRPC's SFY 2021-2024 Transportation Improvement Program (TIP). Mr. Ruzinsky seconded the motion. The motion passed unanimously.

VI. INFORMATION ITEMS

A. TRAC Solicitation Update for Considering Major New Capacity Projects

Mr. Daniel presented an update regarding this year's TRAC solicitation. He stated the TRAC project solicitation began May 1, 2022 and applications are due to ODOT and MVRPC by May 31, 2022. MVRPC will work in coordination with ODOT to acknowledge and review all TRAC applications within the MPO region for the current solicitation. He then shared the links to <u>TRAC's Policies and Procedures</u>, Application Guidelines and Application forms and <u>MVRPC Project Evaluation System (PES) Criteria</u>.

B. Bike Month

Mr. Lindsay and Ms. Henry provided information for Bike Month. Mr. Lindsay first shared an update on the latest <u>Active Transportation Plan draft</u> and said the virtual public meeting was held on May 2nd and the public comment period through May 11th. Mr. Lindsay then shared a brief update on the 2021 Trails User Survey report and was happy to announce the public opinion of the trail maintenance in all counties was rated between good and excellent. He invited members to download the full <u>Trail User Summary Report</u> for more information on perceptions of the trails, economic impacts, and trail user information.

C. Tour de Gem

Mr. Martin introduced Mr. Gerry Chadwick to present information regarding the <u>2022 Tour de</u> <u>Gem-Wright Brothers Cycling Classic</u>. Mr. Chadwick first presented a brief overview of the concept, mission and vision for the cycling fundraising event. He stated the vision is to become one of the preeminent cycling and fundraising events in the Dayton Region and beyond by hosting a fun, family-friendly cycling event that: provides a fundraising mechanism for local nonprofit organizations; delivers a fun, safe and memorable experience for riders; creates public relations value for sponsors and corporate partners; encourages stronger relationships among regional communities and increases the awareness of the Dayton Region as a true GEM. Mr. Chadwick then highlighted some of the nonprofit organizations participating in the past and discussed the future goals for fundraising. Lastly he shared the upcoming event timeline and details and he invited members to become a sponsor, participate, promote the event or volunteer. Mr. Chadwick then opened the floor for questions and asked members to visit the website <u>www.tourdegem.org</u> for more information.

D. MVRPC Member Services Overview

Mr. Martin presented an overview of MVRPC's member services. He first presented the entire MVRPC geography map outlining the various counties MVRPC serves with different capacities such as MPO, RPO, Economic Development District, Rideshare, and the Regional Planning Commission. He then provided more information on each of the services MVRPC offers to Members such as Transportation Planning as the MPO (Long Range Planning and Short Range Planning); Transportation Funding; Economic Development Planning ; Disaster Recovery and Resiliency Planning, Institute for Livable and Equitable Communities, future services for RPO Members; Transit Planning and Funding for Older Americans and Persons with Disabilities; Active Transportation Planning; Comprehensive & Strategic Plans; Rideshare Services; and Water Quality Planning.



RESOLUTION AMENDING THE SFY2021-SFY2024 TRANSPORTATION IMPROVEMENT PROGRAM

WHEREAS, the Miami Valley Regional Planning Commission is designated as the Metropolitan Planning Organization (MPO) by the Governor acting through the Ohio Department of Transportation in cooperation with locally elected officials for Greene, Miami and Montgomery Counties including the jurisdictions of Carlisle, Franklin, Springboro and Franklin Township in Warren County; and

WHEREAS, the MVRPC's Board of Directors serves as the policy and decision making body through which local governments guide the MPO's transportation planning process for the Dayton Metropolitan Area; and

WHEREAS, all Federally funded transit and highway improvements within Greene, Miami and Montgomery County must be included in the region's Transportation Improvement Program (TIP) prior to the expenditure of Federal funds; and

WHEREAS, the SFY2021-SFY2024 Transportation Improvement Program was adopted on May 7, 2020; and

Subject: Adoption of Resolution Supporting the Infrastructure Investment and Jobs Act Performance Management Targets

The Infrastructure Investment and Jobs Act (IIJA) continues to place emphasis on the performance management approach first specified in the Moving Ahead for Progress in the 21st Century Act (MAP-21). It requires state DOTs, transit agencies, and MPOs to establish performance and outcome-based programs in several national priority areas.

While the various rules have different deadlines, generally, after a State DOT adopts targets for a particular rule, MPOs have 180 days from the date targets are established by a State to adopt their own targets or support the State's. The MPO deadline for adopting targets for the second performance period (2022-2026) regarding pavement, bridges, travel time reliability, freight travel time reliability, CMAQ emission reductions, peak hour excessive delay, and non-single occupancy travel is August 19, 2022. MVRPC has decided to support the State's targets for all applicable measures.

Exhibit 1 summarizes measures and targets regarding pavement, bridges, travel time reliability, freight travel time reliability, CMAQ emission reductions, peak hour excessive delay, and nonsingle occupancy travel. Measures described in Exhibit 1 generally apply to the National Highway System only and are adopted every four years.

A resolution to support the IIJA performance management targets as established by ODOT is attached and staff recommends its adoption.

WHEREAS, the Ohio Department of Transportation had to report annual targets for pavement, bridges, travel time reliability, freight travel time reliability, CMAQ emission reductions, peak hour excessive delay, and non-single occupancy travel by February 19th, 2022; and

WHEREAS, MPOs have 180 days to set targets following the above mentioned deadlines; and

WHEREAS, MVRPC working with the Ohio Department of Transportation (ODOT) has chosen to support ODOT's targets.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Miami Valley Regional Planning Commission hereby supports ODOT's performance management targets as outlined in Exhibits 1 and agrees to plan and program projects that contribute to the achievement of such targets.

Subject: Resolution in Opposition to Proposed Federal and State Legislation to Suspend Motor Fuel User Fees

The Board of Directors is asked to consider this resolution opposing proposed Federal and State Legislation to suspend motor fuel user fees.

Concerns over rising gasoline and diesel fuel prices have prompted legislators to propose temporary suspension of certain motor fuel user fees, including gas taxes. At the federal level, legislation has been introduced in Congress to temporarily suspend the 18.4 cents per gallon federal gasoline tax. In Ohio, legislation (SB 277) has been introduced to suspend for five years portion of Ohio's gasoline and diesel user fees including the 10.5 cents/gallon increase for gasoline passed in 2019.

Legislators sponsoring these bills point to the negative impact of recent higher gasoline prices on consumers. In addition, they cite the recently enacted federal Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Law (BIL) which will increase federal funding for the nation's transportation programs over the next five years.

MVRPC opposes these proposals to suspend user fees for several reasons. At the federal level, it should be pointed out that the 2021 IIJA is mostly funded by the Highway Trust Fund, which receives revenue from the federal gas tax and is already underfunded due to increased vehicle fuel efficiency and inflation. Based on Congressional Budget Office estimates, the proposed ten-month suspension of the federal gas tax could deprive the Highway Trust Fund of over \$20 billion intended for surface transportation projects through the IIJA. Any such suspension would seriously undermine the new infrastructure funding by threatening its funding streams and jeopardizing full implementation.

At the state level, SB 277 would temporarily reduce the motor fuel excise tax to 28 cents/gallon for both gasoline and diesel fuel, from the current 38.5 cents/gallon for gasoline and 47 cents/gallon for diesel. The rate reduction would begin on July 1, 2022, or the first day of the first month after the reduction's effective date, whichever is later. MVRPC opposes this legislation and supports maintaining Ohio's gasoline and diesel fuel tax rates at their current levels as enacted in SB 62.

While some have pointed to the IIJA as justification for temporarily suspending the increases enacted in 2019, the new federal law actually supports the need to maintain these additional

state revenues. First, IIJA provides little, if any, funding to help local communities struggling to pay for basic repair and maintenance of local roads that are not part of the federal aid highway system. Second, the state will need to find more state dollars to provide the required state match for many federal funding opportunities created by the law. Ohio motor fuel tax dollars are needed now more than ever.

Also, it should be pointed out that motor fuel taxes are imposed and collected at the wholesale level, rather than on individual consumer transactions at the pump. For that reason, it's entirely unclear whether any gas tax suspension would be passed along to consumers at the pump. Past studies have shown that previous gas tax relief has had little impact on prices at the pump. In other words, these bills to suspend the gas tax might not provide any real relief to consumers, while eroding important sources of funding for our maintenance and repair of our transportation system for the long term and costing consumers more in vehicle repairs.

RESOLUTION IN OPPOSITION TO PROPOSED FEDERAL AND STATE LEGISLATION TO SUSPEND MOTOR FUEL USER FEES

WHEREAS, the Miami Valley Regional Planning Commission is designated as the Metropolitan Planning Organization (MPO) by the Governor acting through the Ohio Department of Transportation in cooperation with locally elected officials for Greene, Miami, and Montgomery Counties including the jurisdictions of Franklin, Carlisle, Springboro and Franklin Township in Warren County; and

WHEREAS, the MVRPC Board of Directors serves as the policy and decision making body through which local governments guide transportation planning for the Dayton Metropolitan Area; and

WHEREAS, Congress and President Biden demonstrated leadership in 2021 by enacting the Infrastructure Investment and Jobs Act (IIJA), increasing funding for the nation's surface transportation programs and providing much needed investments in basic infrastructure to reduce maintenance backlogs and meet the demands of the 21st Century; and

WHEREAS, the IIJA is funded primarily by the Highway Trust Fund, which receives revenue from the 18.5 cents/gallon federal gas tax, of which a proposed ten month suspension could deprive the Highway Trust Fund of over \$20 billion and seriously undermine implementation of the new infrastructure law and limit maintenance of the system;

WHEREAS, Ohio Governor Mike DeWine and the Ohio Legislature demonstrated leadership in 2019 by enacting a SFY 2020-2021 transportation budget that increased the state motor fuel user fee by 10.5 cents, to 38.5 cents per gallon, and increased the diesel fuel user fee by 10 cents to 46 cents per gallon; and

WHEREAS, Ohio's 2019 user fee increase currently generates much needed revenue that will allow the State of Ohio to match new funding opportunities through the IIJA in order to draw down federal dollars for our Ohio; and

WHEREAS, MVRPC strongly supports the concept of transportation funding by user fees – asking those who use the transportation network to pay for maintenance and enhancement which provides predictability for state and local transportation revenues; and

WHEREAS, it is not guaranteed that suspending motor fuel user fees would benefit consumers at the gas pump, due to the fact that fuel taxes are imposed and collected at the wholesale level rather than on individual consumer transactions at the pump, and may erode transportation revenue sources without providing relief to consumers; and

NOW, THEREFORE, BE IT RESOLVED, MVRPC opposes federal and state legislation to temporarily suspend or reduce motor fuel user fees that fund local, state and federal

transportation networks and the Executive Director is authorized to transmit certified copies of this resolution to members of the Ohio and Federal legislatures and other interested organizations.
