The Miami Valley Regional Planning Commission's Institute Steering Committee met on Friday, July 29, 2022 at 9:30 a.m. at MVRPC, 10 N. Ludlow St., Suite 700, Dayton, Ohio 45402. All members and news media were notified of the meeting pursuant to the Sunshine Law.

I. WELCOME AND INTRODUCTIONS

Chairperson Wallace called the meeting to order at 9:30 a.m. Self-introductions were made.

II. APPROVAL OF April 15, 2022 MEETING MINUTES

Ms. Benná made a motion to approve the minutes from the April 15, 2022 Institute Steering Committee meeting. Mr. Hankins seconded the motion. The motion passed unanimously.

V. INFORMATION ITEMS

A. MVRPC Staff Updates

Mr. Martin informed the committee that Leigh Semples accepted a promotion with The Dayton Foundation and that Donna Kastner, a Senior Fellow would be replacing Leigh as our Del Mar Fellow. He also informed the committee that Stacy Schweikhart departed MVRPC to become the CEO of Learn to Earn Dayton.

Mr. Martin briefly discussed the hiring challenges that MVRPC has experienced and how MVRPC is still steadfast on hiring the best talent for the agency.

B. Age-Friendly Initiative Updates

Ms. Benná provided a recap of the Age-Friendly meeting hosted on July 13, 2022. The meeting was focused on healthcare. MVRPC presented the health environment assessment. The group primarily focused on focused on healthcare and on changing the narrative for how older adults are treated in healthcare.

Mr. Martin mentioned how he attended another meeting that was focused on grant funding with the Age-Friendly Cohort. During the Age-Friendly Cohort meeting, Mike Bottomly, the Wright State University Statistical Consultant, spoke and offered his services to help communities implement the community survey that is required to receive grant funding. The purpose of the survey is to gauge community needs when it comes to being age friendly. Mike Bottomly spoke on best practices when conducting the survey and the appropriate questions to ask survey respondents. Mike also offered a free hourly consultation and Wright State's hourly rate for assisting communities implement the survey. Various jurisdictions represented by MVRPC were present. The Village of Yellow Springs shared their experience regarding their community survey.

C. Regional Equity Initiative Updates

Mr. Martin introduced Fabrice Juin, the Regional Equity Initiative Manager at MVRPC and elaborated on the many things that Mr. Juin is currently involved in. Mr. Juin Introduced himself to the Committee and shared his background in Public Health. Mr. Juin provided an updated on the Regional Broadband and Digital Equity Forum held on May 10th at Sinclair Community College. He stated that the Technology & Connectivity Work Group worked on broadband profiles identifying areas with low connectivity and connectivity issues. The affordable connectivity program provides a subsidy for monthly billing and making sure companies are offering plans that meet the subsidy amount to insure that customers can be covered for broadband through the subsidy. The other areas that the Technology & Connectivity Work Group are focused on are education and infrastructure. Mr. Juin explained that it is important to educate communities on how to utilize broadband and how to take advantage of the subsidies being offered and to insure that a firm broadband structure is in place in said communities.

Mr. Juin asked for recommendations to any contacts who may be interested in joining the Technology & Connectivity Work Group. Mr. Hankins recommended inviting companies such as Spectrum and Verizon to forums discussing broadband connectivity as a way to explain the concept to older adults. Chairperson Wallace explained concerns around the VA (Veterans Affairs) implementing a QR code check-in process. The concerns around implementing QR codes for Veterans to check-in at the VA is another instance where people may be left behind, due to lack of knowledge, experience, and familiarity with QR codes.

D. Environmental Justice Academy

The graduation ceremony was held on June 4, 2022 at the UD Curran Place. 21 participants graduated from the program. Four project Ideas were funded through the Piranha Bowl. MVRPC hopes to continue the EJ Academy and facilitate meetings and engagement among the EJ Academy Alumni.

E. The Electric Vehicle Charging Readiness Meeting

The Regional Equity Initiative met with the Electric Vehicle Charging Readiness Meeting to discuss the National Electric Vehicle Infrastructure program and where to place EV charging stations. The placement of EV chargers in underserved neighborhoods is a way to embed equity and prevent said communities from being left behind.

F. County Ambassadors

The Regional Equity Initiative would like to establish County Ambassadors to be the ears and eyes in the communities to identify areas where there is a need to address equity issues. Ms. Wallace added that having County Ambassadors would ensure transparency of information. Ms. Benná added that organizations such as Five Rivers MetroParks would like to be at the table in conversations involving Equity, Environment, Transportation, Health, etc.

Chairperson Wallace recommended that Mr. Juin reach out to the Chambers of Commerce to engage diverse businesses.


VI. ADJORNMENT

"anything can be livable but not everything is equitable" "livability is class oriented"




Ohio's First Age-Friendly Region






PLAN4Health - Miami Valley (Health Environment Assessment Equity Analysis)

Environmental Justice Thriving Communities **Technical Assistance** Centers **Program**

 Provides grant funding to eligible applicants to establish technical assistance centers across the nation providing technical assistance, training, and related support to communities with environmental justice concerns and their partners

 EPA intends to award between 5-10 cooperative agreements under this RFA for approximately up to \$10,000,000 each

- Applying to cover EPA Region 5 (Illinois, Indiana, Michigan, Minnesota, Ohio, Wisconsins, and 35 Tribes)
- University of Dayton serving as lead applicant
