MIAMI VALLEY LONG TERM DISASTER RECOVERY

The Miami Valley will build a comprehensive, long-term disaster recovery system using the National Disaster Recovery Framework (NDRF) to serve all impacted counties & jurisdictions. The NDRF provides guidance to enable recovery by defining recommended roles, responsibilities, coordination and planning among all jurisdictions. Based on decades of disaster response best practices, it focuses on how to restore, redevelop and revitalize the health, social, physical, economic, natural and environmental fabric of community and build resiliency for the future.

There are two major components of the long-term disaster recovery system, Individual Recovery and Community Recovery. Though these branches of the network must work in coordination, they are entirely separate.

The Individual Recovery branch focuses on assisting people impacted by the disaster with their personal and property recovery. The Community Recovery branch focuses on assisting local jurisdictions with planning, policy and coordination efforts designed to accomplish both economic recovery and increased resiliency.

Certainly those working in either branch of the recovery will be interested in supporting each other. Those in the Individual Recovery branch will naturally be interested in policy and planning on issues of concern to them and their work. Likewise, those in the Community Recovery branch genuinely care about helping the people who are struggling personally as a result of the disaster. Each branch will have its own full-time Disaster Recovery Manager and part of their role will be to help individuals and organizations find the best place to plug into the recovery efforts based on resources and to keep both branches of the recovery network appraised of each other's progress.

The common link between the two branches of the long term disaster recovery system will be the Disaster Recovery Managers and the Miami Valley Long Term Disaster Recovery Advisory Committee. This advisory committee will provide high-level advocacy and support for both the Individual and Community long term recovery network efforts. It will be comprised of elected officials and executive leaders from local governments, school districts, education institutions, business organizations, utility providers and community foundations.

LONG TERM INDIVIDUAL DISASTER RECOVERY NETWORK

The Long Term Individual Disaster Recovery Network, functioning currently as the Disaster Recovery Operations Group, will coordinate the efforts of critical non-profits, social service agencies and foundations to meet the recovery needs of individuals impacted by the disaster.

The recovery timeline for the Individual Network is one to three years.

The Long Term Individual Disaster Recovery Network will be led by Disaster Recovery Manager and a Board representing the involved organizations.

Within the Individual Network, well established groups will focus efforts on the following areas:

LONG TERM COMMUNITY DISASTER RECOVERY NETWORK

The Miami Valley Regional Planning Commission will be the designated leader of the Long-Term Community Disaster Recovery Network. Community Recovery engages local governments to coordinate the application for, distribution of and progress reporting for disaster aid funding from multiple federal sources.

The central focus of Community Long-Term Recovery is the intentional and strategic incorporation of mitigation actions and inclusive, comprehensive planning in recovery decision making. This results in resiliency and preparedness for future disasters.

The recovery timeline for the Community Network is one to ten years.

The Long Term Community Disaster Recovery Network will be led by Disaster Recovery Manager hired by MVRPC and a committee of representatives from impacted communities.
