The Miami Valley Regional Planning Commission Regional Transportation Planning Organization Steering Committee met on February 19, 2025 at 2:00 p.m. at Shelby County Agriculture Center, 820 Fair Road, Sidney, OH 45365. All members and news media were notified of the meeting pursuant to the Sunshine Law.

# I. INTRODUCTION

Vice-Chairperson Sommer called the meeting to order at 2:00 p.m. Self-introductions were made.

# II. APPROVAL OF THE NOVEMBER 20, 2024 MEETING MINUTES

Mr. Knupp made a motion to approve the meeting minutes. Mr. Barhorst seconded the motion. The motion passed unanimously.

# III. Public Comment Period on Action Items

None

# IV. RTPO (REGIONAL TRANSPORTATION PLANNING ORGANIZATION) ACTION ITEMS

#### A. Resolution 25-04: Approval of Recommended Project for DPS Regionally Controlled RSTP Funds

Ms. Ramirez presented the proposed Regional Surface Transportation Program (RSTP) project list for funding with MVRPC's regionally controlled funds. She stated that upon Board approval, the project sponsor and ODOT District Office staff to determine a detailed project scope and an anticipated development schedule. Based upon this determination, a final funding year will be recommended for official incorporation into the MVRPC Darke-Preble-Shelby Regional Transportation Improvement Program. Lastly, Ms. Ramirez noted staff recommends forwarding the recommended project for DPS Regionally Controlled RSTP fund to the Board of Directors.

February 19, 2025 2:00 PM She then opened the floor for questions and discussed the Ohio State budget proposal of removing funds for the RTPO Capital Program.

Mr. Barhorst made a motion to recommend forwarding to the Board of Directors for adoption. Ms. Vonderhaar seconded the motion. The motion passed unanimously.

# V. INFORMATION ITEMS

# A. Functional Classification Update information

Ms. Wilson presented an overview of the Functional Classification Update process. She explained that the comprehensive update occurs every 10 years and determines eligibility for federal transportation funds, which also impacts roadway design criteria and expectations. She then explained that the 2020 update introduced key changes, such as deemphasizing classification changes at urban boundaries, keeping the same numbering system for urban and rural areas, and allowing freeways in rural areas and minor collectors in urban areas. Additional factors like system continuity, route spacing, speed, and AADT (> 3,000 for new urban collectors) were highlighted. She then shared the descriptions for the single numbering system.

Ms. Wilson provided an update schedule, noting that jurisdictions must submit proposed changes to MVRPC by March 7<sup>th</sup>. A draft classification will be presented to the RTPO Steering Committee on April 16<sup>th</sup>, with final adoption scheduled for June 5<sup>th</sup> before forwarding the changes to ODOT. Lastly, she shared the <u>website</u> where members can view existing classification maps for their areas.

# B. Discuss Regional Transportation Improvement Program Public Participation

Ms. Ramirez explained that the Regional Transportation Improvement Program (RTIP) public participation meeting is scheduled for March 25<sup>th</sup> from 5:00-6:00 p.m. She then stated that information will also be available for public review on MVRPC's website at <u>rtpo.mvrpc.org</u> and at a central location in each RTPO county. The following locations were agreed upon:

# C. Facility Planning Area Outreach in 2025

Mr. Lindsay first introduced Ms. Rebecca Carr as MVRPC's Active Transportation & Environment Planner. He then provided an overview of MVRPC's upcoming Facility Planning Area (FPA) Outreach initiative scheduled for 2025. He explained that as the Areawide Water Quality Planning Agency, MVRPC is responsible for maintaining a regional water quality management plan, including the designation of local management agencies (DMAs) and their wastewater facility planning areas.

He stated that MVRPC will proactively reach out to DMAs to gather input on any needed updates to ensure that local plans are up to date and reflect community growth and development. Each community will receive a letter and baseline data packet, including maps, population projections, and recent facility flow data. The effort will begin with outreach to Darke County. Lastly, he opened the floor for questions and discussed that staff will need to work with the Ohio EPA and Shelby County for designation.

# VI. OPEN MEMBER DISCUSSION

Ms. Ramirez invited the RTPO Steering Committee members to share and discuss transportation-related topics.

Subject: Adoption of the SFY 2026-2029 Regional Surface Transportation Improvement Program (RSTIP)

The RTIP is a comprehensive and financially-constrained listing of regional transportation projects and services that are scheduled for some phase of implementation within the four year STIP period. The projects identified in the RTIP were selected through a continuing and cooperative planning effort between the Darke-Preble-Shelby RTPO, the State of Ohio, and local communities. They are in alignment with the goals of the DPS 2050 Regional Transportation Plan that was adopted in June 2024. The projects have funding commitments from a variety of federal, state and local sources and all regionally significant projects are included in the RTIP. The program of projects maintains a balance of local and regional needs, and includes projects from all modes of transportation including highways, public transportation or transit, bike facilities, and pedestrian facilities.

Staff has closely coordinated the development of the RTIP with all project sponsors including local jurisdictions, transit operators, and ODOT. Staff held a public involvement meeting to present the Final Draft RTIP on March 25<sup>th</sup>. No public comments have been received to date.

The RTIP includes highway and bikeway projects which are entered into ODOT's ELLIS project tracking system to help develop milestones and establish dates when projects will require federal funding authorizations through the STIP/RTIP. Projects are entered into and tracked through ELLIS by establishing a project identification (PID) number. ODOT tracks programmed projects to ensure they meet development milestones and completion dates and the STIP/RTIP then allocates federal funding as needed for preliminary engineering (ENG), right of way (ROW), and construction (CON).

The Final SFY2026-2029 RTIP includes Tables 4.2 and 4.3 which list highway, bikeway, and other improvements for which some phase of work will be advanced during SFY2026-2029. As required by ODOT, projects are sorted in the tables by the "County-Route-Section" number. Any federally funded phases of work during SFY2026-2029 must be approved by the FHWA prior to the encumbrance of federal funds.




MVRPC staff worked with ODOT and local jurisdictions in February and March to review and update the functional classification of roads. The results can be seen in the attached map.


# Settling In: MVRPC's Move, Office Updates, and NATO Impacts



MVRPC began moving into our new office location at <u>6 North Main Street, Suite 400</u> in Dayton on December 26, 2024. The team of Mike Lucas, Elizabeth Baxter and Savannah Diamond, IT consultants, and move vendors made the process of moving easier for the remainder of the team. Periodic contributions by all members of the staff as they began to report to the new office from January 3, 2025 through current has made the sterile office shell start to look and feel like MVRPC offices. Staff contributions from setting up the kitchen, organizing furniture, installing pictures, setting up the conference rooms as well as their personal offices were greatly appreciated. Every

aspect of forming our new home: parking locations, vehicle loading and unloading, using the loading dock, what to do and where to go in case of emergencies, wi-fi and use of computer, use of A/V, drinking water, furniture assembly, use of elevators and stairs has been tested and procedures developed so far.

A wrinkle in our planning has been the <u>NATO Parliamentary</u> <u>Assembly</u> and associated street and sidewalk improvements around Courthouse Square, the proposed NATO Village. From what we learned last week during our first formal update meeting on NATO Village, due to logistical challenges of the NATO Parliamentary Assembly, our physical office will be closed to staff and the general public from Tuesday, May 20th through Monday, May 26<sup>th</sup> (Memorial Day Holiday). Staff will work virtually during this time. We include the holiday because this is the final day of the NATO meetings.



The NATO Village security perimeter will be in place from May 20th to May 27th, with restricted access to the area, limited parking, and expected traffic congestion. The Arts Garage will be limited to parliamentarians and their guests.

We are asking officials when the perimeter will be fully disassembled so that we can resume our in-office schedules on May 27. If they can't ensure opening by 7:00 a.m. on Tuesday, we'll add May 27 to the office closure calendar.

Other necessities still under construction in the office includes:

- 1. Addressing cool airflow in the east-facing offices
- 2. Purchasing additional blinds for the interior offices
- 3. Landlord purchasing replacement blinds in some exterior offices
- 4. Purchasing shelving for our library
- 5. Hanging photos throughout our offices
- 6. Customizing light brightness choices in select offices
- 7. Purchase and installation of audio video equipment.

While we certainly enjoy the modern look of our new space compared to our former location which was our home for 10 years, the change has been challenging. We remain optimistic that the remaining necessities will be installed and addressed prior to our planned Open House which is currently contemplated for early June.

# **MVRPC** Releases the Healthy Communities Needs Assessment

MVRPC is pleased to announce the publication of the Healthy Communities Needs Assessment, the sixth project of the PLAN4Health - Miami Valley Initiative. In the spring of 2024, a survey was sent to jurisdictions across the Miami Valley asking questions designed better understand current planning practices, learn about the barriers and opportunities facing communities, and identify resources that are needed to advance planning for healthier communities in the Miami Valley Region. The findings from these survey responses are now available at <u>Healthy Communities Needs</u> <u>Assessment (https://arcg.is/194mWb)</u>.



MVRPC's PLAN4Health – Miami Valley Initiative was launched in the spring of 2021 to explore how planning can impact health outcomes. This multi-year effort with a focus on projects and programs intended to:

- Promote and advocate for "Health in All Plans and Policies"
- Convene and engage partners to improve conditions known to be key determinants of health
- Advance planning efforts aimed at creating conditions for healthy people and communities

The <u>Healthy Communities Needs Assessment</u> covers four major topic areas related to planning and health: 1) Community Conditions for Health; 2) Active Living Community Assets; 3) Active Living Policies and Strategies; and 4) Planning Capacity and Resources. The information gathered from the survey revealed a number of barriers that are preventing communities from planning for health as effectively as they could be. Conversely, survey responses provided many great insights related to opportunities to break down these barriers.

The information from the <u>Healthy Communities Needs Assessment</u> will be used during the upcoming **The Healthy Communities Planning Toolkit** project.
