- ◆ Culminates in beginning community Urban Forest Management Plan







2019 DEPLOYMENT

- ❖ City of Dayton, Wright Patt.AFB, and City of Beavercreek
- ❖ Tree Risk Assessments
 - ❖ FEMA & ISA Standards
- ❖ Goals: Increase public safety, reduce loss of urban tree canopy, and document recovery needs
- ❖ Seven, 2-Person Crews
 - ❖ Nine Communities, ODNR, USFS, & Ohio State University





DAYTON

- Hosted the Ohio Urban Forestry Strike Team
- Surveyed 4 impacted neighborhoods
 - DeWeese Neighborhood
 - Riverdale Neighborhood
 - Old North Dayton Neighborhood
 - Wright View Neighborhood

HARRISON TOWNSHIP'S SINCLAIR PARK

- Successful Tree Planting of 60 trees and arrangements for their ongoing maintenance
- Management plan development
 - Service Forester Justin Law
 - honeysuckle and tree-of-heaven control



BEAVERCREEK

- Assisted city and tree commission with Arbor Day Foundation (ADF) Community Tree Recovery proposal
- The Beavercreek Wetlands Association distributed 500 trees
 - FedEx funding \$25/tree



WRIGHT PATTERSON AIR FORCE BASE

- Received \$30,000 ADF tree planting grant and planted 100 trees at the Prairie Housing Development including tools and establishment
- Annual Arbor Day at Wright Brothers Memorial
 - 30 trees with Fairborn Students
- WPAFB Earth Day at Huffman Prairie
 - Honeysuckle removal and tree planting



Storm Preparedness

- ☐ Employee Responsibilities/Chain of Command
- ☐ Debris Management Plan
- ☐ Pre-Event Contracts with Tree Company ~ ISA Certification
- ☐ Tree Ordinance
- ☐ Contract Ready Specifications
- ☐ In House Expertise – City Forester/ISA Certified Arborist

Pre-Event Contracts

There is a limited number of contractors and equipment capable of performing this type of work.

During a widespread event you may have a tough time locating a qualified contractor. Worse yet, you could end up with an unqualified contractor.

Storm Preparedness

Once an event occurs, it is usually too late to make policy actions. Prior planning and strong policy are key to successfully integrating FEMA Debris Management with tree preservation.

In FEMA's Debris Removal Program, trees are an afterthought. The contractors that normally perform this work are not arborists. They usually have no background in tree work.

Most FEMA Debris Removal Contracts are set up to reward the contractor for tree removal. This is unwittingly set up and results in removal of trees that could be retained.


Local Ordinances

FEMA respects local ordinances but will not respect your wishes or desires. These policies must be in effect prior to the event.

- Adopting the ANSI standards
- Permit process to remove public trees
- Minimum crew qualifications
- Equipment safety inspections
- Require ISA Certified Arborists on crew
- Adopt specific policies for storm work
