**Subject:** Input Meetings to focus on Transportation Needs in Greene, Miami, Montgomery, and Northern Warren Counties for Older Adults, Individuals with Disabilities and the General Public

The Miami Valley Regional Planning Commission (MVRPC) is updating the Coordinated Human Services Transportation Plan for the Region. A series of input meetings will be held to listen to anyone who rides, would like to ride, and/or operates public, private or human service agency transportation resources, and to inform interested individuals about the possibilities of coordinated public and human service agency transportation.

The meetings will begin with a brief presentation of the plan's purpose. The presentation repeats at the top of the second hour of the meeting. Following the presentation there will be an open discussion about specific needs for transportation to work, medical appointments, entertainment, or any other destination. Public, private, and non-profit transportation providers, human service agencies, and any individual who needs transportation should attend.
