

RTPO Background

- In 2012, the Moving Ahead for Progress in the 21st Century allowed states to formally designate Regional Transportation Planning Organizations to help the State DOTs conduct the nonmetropolitan transportation planning process.
- Following pilot programs, 6 RTPOs have been designated in Ohio.

RTPO Pilot Program Goals

- Adopting a multi-modal long-range transportation plan for the region
- Having a formalized consultation process with rural communities
- Developing transportation planning expertise
