# A. Recommended Adoption of Amendment to MVRPC's SFY2018-2021Transportation Improvement Program (TIP)

Mr. Arnold referred to a memo on page 5 of the mailout explaining that numerous modifications to the programming documents for various projects has resulted in the need for a TIP amendment. He referred to the project tables for each county, as well as the statewide line item projects. He noted that there was a new format for the tables as a result of a recent web TELUS update.

Mr. Arnold stated that staff does recommend adoption of this TIP amendment, and referred to a resolution on page 14 of the mailout. Ms. Rhoades made a motion to recommend adoption. Mr. Donnelly seconded the motion. The motion passed unanimously.

# B. Recommended Adoption of Resolution Supporting MAP-21/FAST Act Safety Performance Management Targets

Ms. Parikh referred to a memo on page 15 of the mailout explaining MAP-21/FAST Act requires state DOT's, transit agencies and MPO's to establish performance and outcome-based programs in several national priority areas. After a rule is final, MPO's have 180 days from the date the targets are established by a State DOT to adopt their own targets or support the State's targets. Ms. Parikh noted that the MPO deadline to adopt the safety performance management targets is February 27, 2018. She stated that staff recommends adoption of the resolution on page 17. Mr. O'Connor recommended adoption. Mr. Conway seconded the motion. The motion passed unanimously.

#### VI. EXECUTIVE DIRECTOR'S REPORT

Mr. Martin referred to his October report on page 18 of the mailout that provided announcements about recent GIS awards presented to MVRPC, Rideshare Week, Grant & Funding resources as well as a list of upcoming meetings. He also provided an update on the 2017 TRAC hearing that was held on October 12<sup>th</sup>. At the hearing, MVRPC presented 2 projects, MOT US 35 Widening and GRE US 35 at Valley/Trebein Interchange. Mr. Martin reported that Laura Toole, from FHWA is working on the report from the recent Certification Review, which should be available shortly. He noted that the December TAC and January Board meetings would be cancelled.

# RESOLUTION AMENDING THE SFY2018-SFY2021 TRANSPORTATION IMPROVEMENT PROGRAM

**WHEREAS**, the Miami Valley Regional Planning Commission is designated as the Metropolitan Planning Organization (MPO) by the Governor acting through the Ohio Department of Transportation in cooperation with locally elected officials for Greene, Miami and Montgomery Counties including the jurisdictions of Carlisle, Franklin, Springboro and Franklin Township in Warren County; and

**WHEREAS**, the MVRPC's Board of Directors serves as the policy and decision making body through which local governments guide the MPO's transportation planning process for the Dayton Metropolitan Area; and

**WHEREAS**, all Federally funded transit and highway improvements within Greene, Miami and Montgomery County must be included in the region's Transportation Improvement Program (TIP) prior to the expenditure of Federal funds; and

**WHEREAS**, the SFY2018-SFY2021 Transportation Improvement Program was adopted on May 4, 2017; and

WHEREAS, MVRPC, ODOT and GDRTA have made numerous modifications to the programming documents for various projects resulting in the need for a SFY2018-SFY2021 TIP amendment; and

**WHEREAS**, the proposed amendment is consistent with the Region's long-range transportation plan; and

**WHEREAS**, this TIP amendment will not affect the regional air quality emission analysis of the SFY2018-SFY2021 TIP; and

**WHEREAS**, the MVRPC Public Participation Policy for Transportation Planning process allows for minor TIP amendments such as this to occur without separate public involvement meetings; and

WHEREAS, this amendment will result in a TIP that is in reasonable fiscal constraint

**Subject:** Resolution to Authorize Use of MVRPC STP Funds for the US 35 Widening

Formed in 1997, by request of the Ohio Department of Transportation (ODOT), the Transportation Review Advisory Council (TRAC) is a permanent body of predominantly non-ODOT personnel, which administers the project ranking and selection process for all major new projects in Ohio. To learn more about the TRAC please visit their web site at: http://www.dot.state.oh.us/trac/Pages/Default.aspx.

An application for the widening of US 35 in Montgomery County from Livingston Avenue to the Montgomery/Greene County Line was submitted to TRAC in October requesting construction funding in the amount of \$11,620,000. At the time of the application submittal, there was no local funding committed to the project. TRAC's scoring criteria gives preference to projects that include a local funding match to the TRAC request. In recent years, the US 35 Widening has been the MVRPC #1 ranked project for TRAC funding consideration.

Since the submittal of the application to TRAC, staff has had preliminary discussions with ODOT staff involving a scenario in which MVRPC Surface Transportation Program (STP) funding including Toll Revenue Credit (TRC) could be used as the local funding match in the TRAC request. TRAC considers regional MPO funding as local / non ODOT funding. If MVRPC STP funding were committed to the MOT US 35 project, it would gain additional points in TRAC's ranking due to the addition of local funding and the amount of TRAC funding would be reduced.

TRC exists in states with toll roads because tolling raises funds for the operation and maintenance of toll roads and indirectly for other roadways across Ohio. FHWA allows use of TRC as "soft match" to federal funds due to Ohio's collection of toll revenue. TRC enables use of Federal funding in lieu of local cash match. ODOT has allowed MPOs to use TRC since 2015. Each MPO has assigned to it a TRC budget that could be used for major projects. The negative impact on the MPO is the use of TRC uses more federal funding for one project. Without leveraging funds with local cash match, our STP funds will not go as far. Thus, the agency will be very selective in using this resource.

The construction cost for the widening has dropped 33.3% from \$21M last year to \$14M due to ODOT's active review of the design plans. Since the cost has been reduced, MVRPC funding combined with TRC now has the opportunity to provide nearly all of the local match goal of 30% established by TRAC for this year. The funding requested of TRAC has dropped by 25% from \$11.62M to \$8.7M due to this solution. Now is the time to move this widening project forward.

On November 2, 2017, upon learning about this TRC resource, the Board of Directors granted the Executive Director consent to negotiate with TRAC in order to secure construction funding for US 35 Widening. The Executive Director is authorized to conduct further discussion with ODOT offering up to \$3 million in MVRPC STP funding including TRC in order to secure more construction funds from TRAC. The commitment of MVRPC STP funding to the US 35 widening project is contingent upon TRAC's commitment of the balance of necessary construction funding to complete the project. These funds for construction will be available after the current solicitation for project funding concludes which would be in FY 2024. Thus, this request has no impact on the current solicitation. The attached resolution authorizes up to \$3M in MVRPC-attributable STP funds for the Montgomery US 35 widening project.

# RESOLUTION AUTHORIZING USE OF MVRPC ATTRIBUTABLE STP FUNDING FOR THE US 35 WIDENING

**WHEREAS**, the Miami Valley Regional Planning Commission is designated as the Metropolitan Planning Organization (MPO) by the Governor acting through the Ohio Department of Transportation in cooperation with locally elected officials for Greene, Miami and Montgomery Counties including the jurisdictions of Carlisle, Franklin, Springboro, and Franklin Township in Warren County; and

**WHEREAS**, the MVRPC Board serves as the policy and decision making body through which local governments guide the MPO's transportation planning process for the Dayton Metropolitan Area; and

**WHEREAS**, the Ohio Department of Transportation (ODOT) has created the Transportation Review Advisory Council (TRAC) to develop and implement a decision making process to direct the major new capacity investment decisions of ODOT; and

**WHEREAS**, ODOT's TRAC Scoring Criteria gives preference to projects that include a local funding match in the TRAC funding request; and

WHEREAS, TRAC considers the use of MVRPC Federal funding as local funding from the Region; and

**WHEREAS**, staff has reviewed with the TAC, MVRPC Board of Directors and ODOT a scenario in which MVRPC STP funding including Toll Revenue Credit may be used as the local match to the TRAC funding request; and

**WHEREAS**, MVRPC has reviewed its future funding commitments and has identified 2024 as the next fiscal year with sufficient budget to fund this request.

**NOW THEREFORE BE IT RESOLVED**, that Miami Valley Regional Planning Commission's Board of Directors hereby authorizes the Executive Director to enter into negotiations with TRAC to secure construction funding for MOT US 35. The Executive Director is authorized to offer up to \$3 million MVRPC STP funding including Toll Revenue Credit in order to secure TRAC construction funds for MOT-35. The commitment of MVRPC STP funding to the MOT-35 project is contingent upon TRAC committal of the balance of necessary construction funding to complete the project.

### **MVRPC Receives Federal Certification Report of Planning Process**

The federal review team, lead by Laura Toole, Federal Highway Administration, Ohio Division, and Reggie Arkel of the Federal Transit Administration, Region V, has completed their draft MVRPC

Certification Review Report. Through a combination of remote desk reviews, a public meeting, and the onsite discussions on August 29 & 30, the review team was able to determine, as written in the report, "The planning process as conducted by MVRPC, Ohio Department of Transportation, GDRTA, Greene CATS, and Miami County Transit meets the requirements of the metropolitan planning regulations per 23 CFR 450. As such the Review Team Certifies the planning process." On behalf of the Miami Valley, MVRPC's Board of Directors, committees, and staff, we are grateful to our planning partners and the review team for an outstanding metropolitan planning process and we are excited about the future work that we will complete on behalf of the Region.

**Commendation 1:** MVRPC and its partners are commended for the Going Places initiative.

**Commendation 2:** GDRTA is commended for receiving the Certificate of Merit for Security from the American Public Transportation Association (APTA).

**Commendation 3:** MVRPC and GDRTA are commended for their work on improving bicycle and pedestrian transportation, including the regional Complete Streets Policy, Bikeway Plan and Level of Traffic Stress analysis, bike share program, and coordination with park districts.

**Commendation 4:** MVRPC is commended for receiving two awards at the 2016 Ohio GIS Conference: Miami Valley Regional Vacancy Profile map received the People's Choice Award and 2014 Miami Valley Employment story map received the Second Place Award in the Digital Map Category.

**Recommendation 1**: MVRPC should coordinate with its local public agencies to identify which entities have ADA Transition Plans in place and promote compliance with the ADA/504 requirements,

**Recommendation 2**: MVRPC should not establish standard benchmark goals when reviewing proposals or DBE Program goals. Instead, MVRPC should coordinate goal setting guidance and overall DBE Program requirements with ODOT.

**Recommendation 3**: ODOT should provide guidance to Ohio MPOs, including MVRPC, on DBE Program Goals.

**Recommendation 4**: To improve transparency relative to fiscal constraint, MTP implementation, and compliance with 23 CFR 450.324(g)(11)(i)&(iv), the next MTP should identify proposed major capital projects and operations and maintenance costs to fully capture their program.

## MVRPC Hosts the Miami Valley Equity Initiative Kickoff Listening Session

Now that the equity study is complete, MVRPC hosted a Listening Session with representatives from various public and non-profit agencies on Thursday, October 26. The goal was to determine next steps for increasing equity in our Region by using the input from these experts who have been working on this issue.

The 17 participants represented the following organizations: Sinclair Community College, Miami Valley Urban League, National Conference for Community and Justice, United Way, PNC Bank, Human



Relations Council, and Learn to Earn Dayton. The two-hour discussion was facilitated by the OSU-based Kirwan Institute for the Study of Race and Ethnicity. The session summary is being prepared and we will share it when it is completed.

MVRPC will be leading a session titled "Let's Talk about Inequity in the Miami Valley" at the upcoming Miami Valley Planning and Zoning Workshop on Friday, December 1, at Sinclair Community
