# **State Energy Security Plan**

# Education and Outreach

Available Funding: \$795,590 Eligible Applicants:

Public entities and nonprofits (colleges, universities, county sponsored career centers, nonprofit organizations, engineer/architect education and outreach/sponsored programs).

### **Eligible Projects:**

Energy audit training for higher education students, and K-12 energy efficiency and renewable energy learning programs.

#### **Application Period:**

Request for Proposals opening in summer/fall 2023.

## Energy Efficiency Program for Ohio Communities

Available Funding: \$8,000,000 Eligible Applicants:

Local governments. See guidelines for more information on eligible applicants.

### **Eligible Projects:**

Energy efficiency retrofits on existing buildings, including heating, ventilation and air-conditioning (HVAC) upgrades, insulation, lighting installation, etc.

#### **Program Requirements:**

Projects are expected to result in a minimum of 15% energy savings based on an engineer/architect-approved ASHRAE II energy audit that is less than two years old.

### **Application Period:**

Applications open July 1, 2023.

# Energy Efficiency Program for Ohio Communities Audit Support

Available Funding: \$1,000,000

**Eligible Applicants:** 

Small businesses, manufacturers, and public entities and nonprofits (local governments, school districts, nonprofit organizations).

### **Eligible Projects:**

Energy efficiency retrofits on existing buildings, including heating, ventilation and air-conditioning (HVAC) upgrades, insulation, lighting installation, etc.

## **Program Requirements:**

Applicants must obtain an ASHRAE II energy audit from a Development-approved auditor to be eligible for grant funds.

## **Application Period:**

This program is now open. Please contact a Development-approved energy auditor to apply.

# Renewables and Grid Resiliency

Available Funding: \$2,000,000 Eligible Applicants:

Public entities and nonprofits (colleges, universities, local governments, nonprofit organizations), commercial businesses and manufacturers.

#### **Eliqible Projects:**

On-site renewable energy/grid resilient applications and projects that generate electricity from non-depletable sources of energy and/or support grid resiliency.

#### **Program Requirements:**

Projects are expected to result in a minimum of 15% energy savings based on an engineer/architect-approved ASHRAE II energy audit that is less than two years old. Applicants must submit supplemental application materials outlining the project and adhere to compliance with additional requirements.

### **Application Period:**

Request for Proposals opening in fall 2023.

# **Energy Efficiency Conservation Block Grant**

Total Funding: \$3,130,030

# **Programs: TBD**

This program is designed to assist states, local governments and tribes in implementing strategies to reduce energy use and fossil fuel emissions, and improve energy efficiency. The Ohio Department of Development's Office of Energy and Environment is in the process of applying for this program. Applications are due in summer 2023.



# **Energy Efficiency Revolving Loan Fund**

Total Funding: \$3,202,320

# **Programs: TBD**

This program is designed to provide capitalization grants to states so they can establish a revolving loan fund for providing loans and grants for energy efficiency audits, upgrades, retrofits. The Ohio Department of Development's Office of Energy and Environment is in the process of applying for this program. Applications are due in late-spring 2023.
