The Miami Valley Regional Planning Commission Regional Transportation Planning Organization Steering Committee met on May 17, 2023 at 2:00 p.m. at the Preble County Fairgrounds/Expansion Building, 722 S. Franklin Street, Eaton, OH 45320. All members and news media were notified of the meeting pursuant to the Sunshine Law.

I. WELCOME AND INTRODUCTIONS

Ms. Ramirez welcomed everyone and began the meeting at 2:00 p.m. Self-introductions were made.

II. PROJECT SUBMISSION

Ms. Ramirez provided information on Regional Transportation Plan projects. She explained that the plan focuses on larger projects such as lane additions, intersection improvements, safety projects and new bikeways. She then provided information on how to submit Regional Transportation Plan Projects using the [Project Profile Form](#). Lastly, Ms. Ramirez stated the deadline to submit projects will be August 16, 2023.

III. BIKEWAY WORKSHOPS SUMMARY

Ms. Ramirez provided a summary of the Bikeways Workshop hosted on March 15, 2023. The Purpose of the workshop was to bring together all three counties to discuss their plan/projects for the regional bikeway system.

IV. SAFETY ANALYSIS AND PRIORITY LOCATIONS

Ms. Wilson provided information regarding the [Regional Safety Analysis \(2019-2021\)](#). She stated that the goals of the analysis were to monitor crash trends, locate high crash locations, and to make roadway improvements. Lastly, Ms. Wilson shared the data of the analysis.

V. VULNERABLE POPULATIONS AND LIMITED ENGLISH PROFICIENCY

Ms. Benefiel provided information regarding the vulnerable populations and populations with limited English proficiency (LEP) within the RTPO region. She stated that the goal is to ensure environmental justice and equity is at the forefront of the analysis. MVRPC conducts assessments of vulnerable populations and populations with LEP. The analysis is done through qualitative and quantitative means using 2020 Census and 2016-2020 ACS data and GIS. Ms. Benefiel then shared the data broken down by each county.

VI. OUTREACH EFFORTS TO ENVIRONMENTAL JUSTICE AND LEP POPULATIONS

Ms. Ramirez asked the Sub-Committee to discuss outreach ideas to the vulnerable populations and populations with LEP. The Sub-Committee discussed the following options: Jobs & Family Services, Churches, School Systems, Health Departments, and Restaurants. Ms. Ramirez stated that public outreach will be used for sending information regarding our public meetings.

VII. ADJOURN

Ms. Ramirez announced the next full in person meeting will be Wednesday, August 16th and adjourned the meeting at 3:00 p.m.

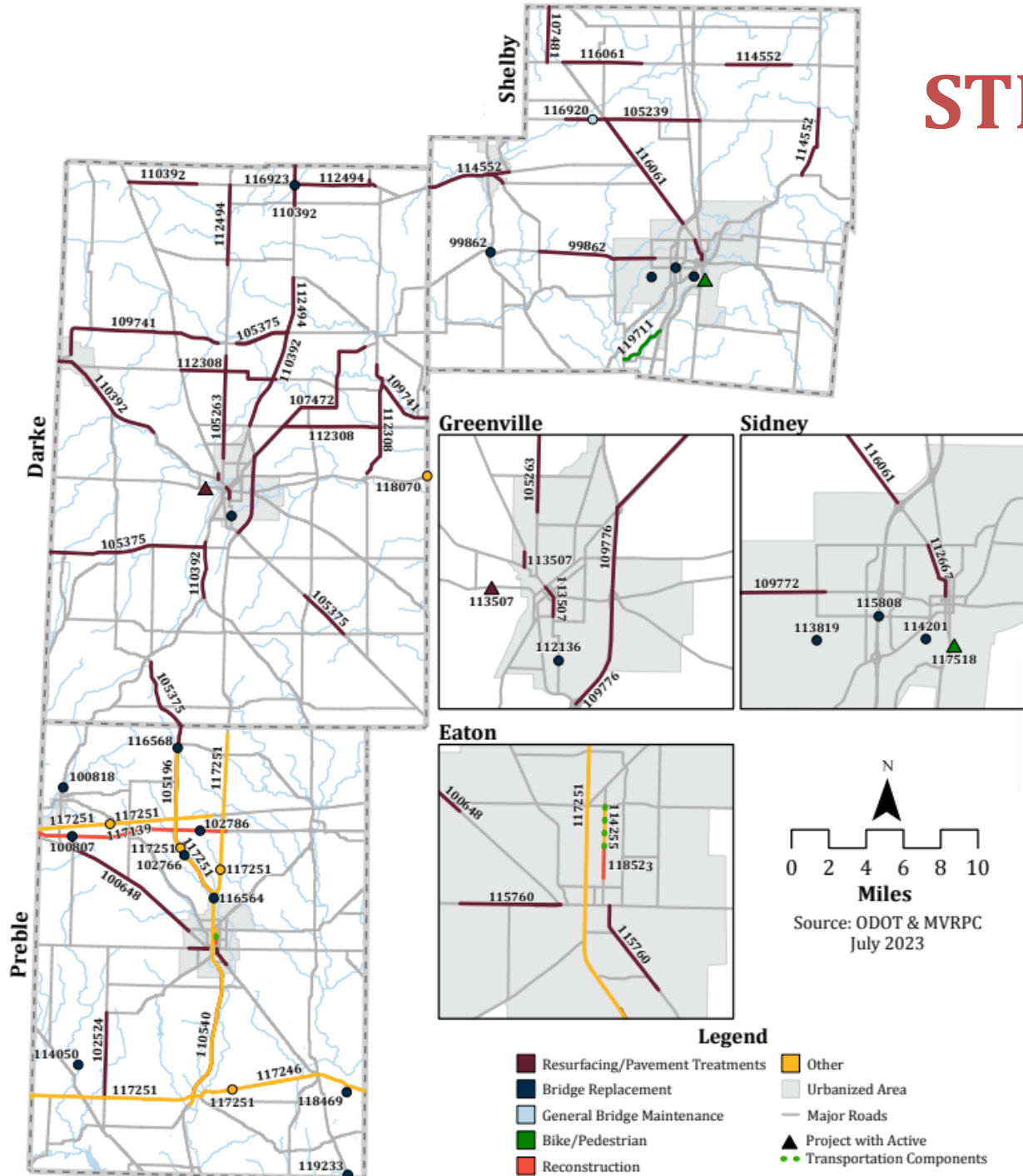
What is the STIP?

- All projects that receive federal or state funding **must** be included in the STIP



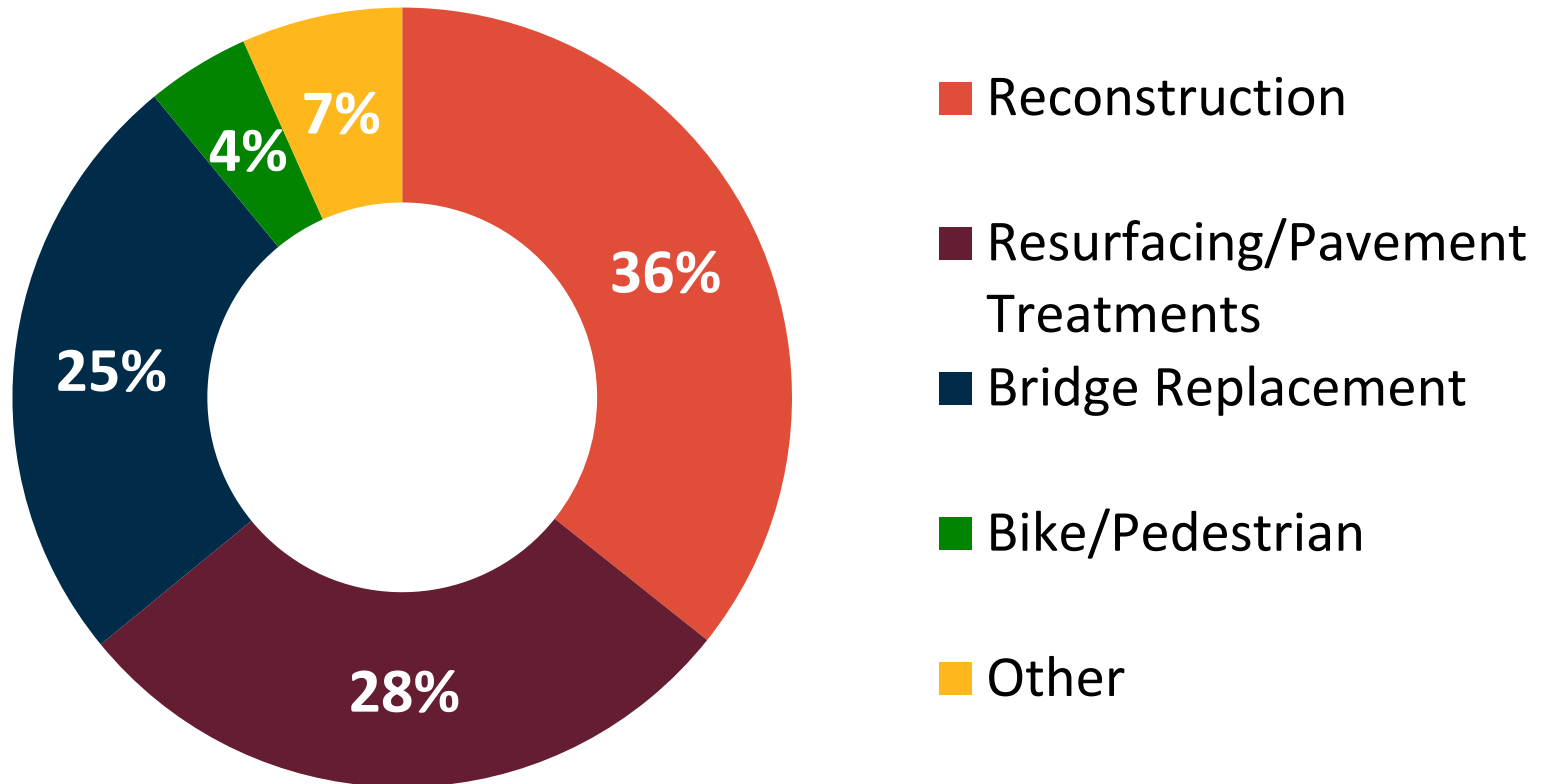
STIP Project Map

- 12 in Darke



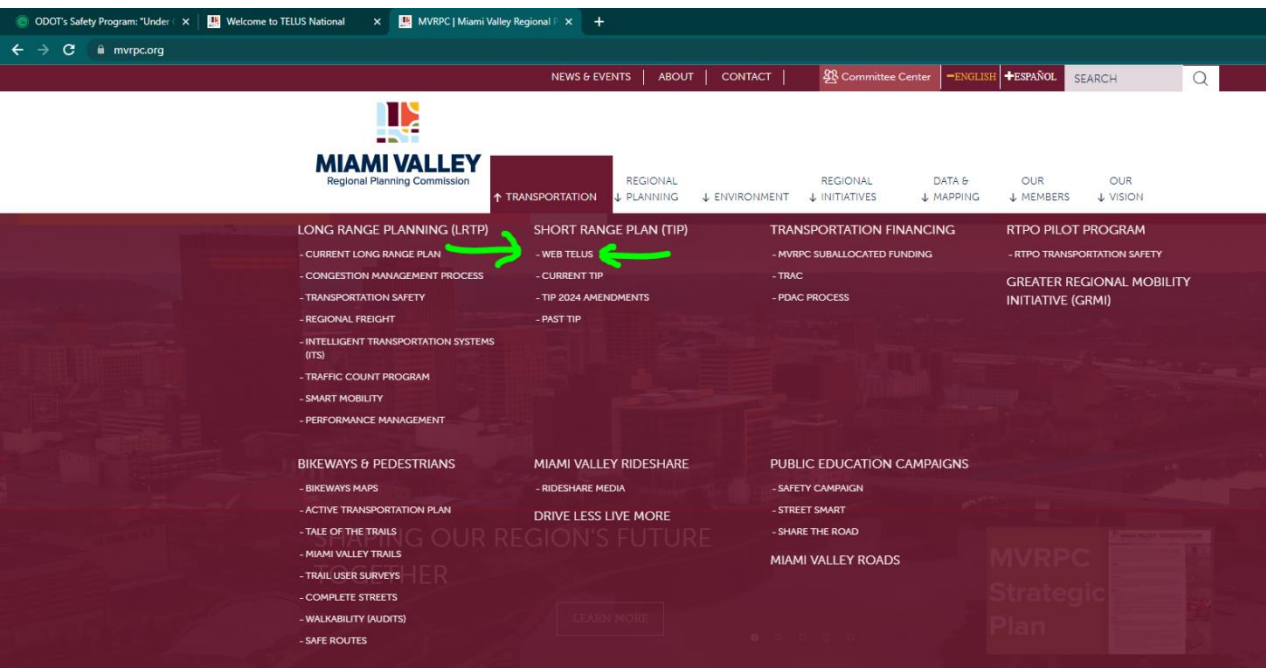
Regional STIP Stats

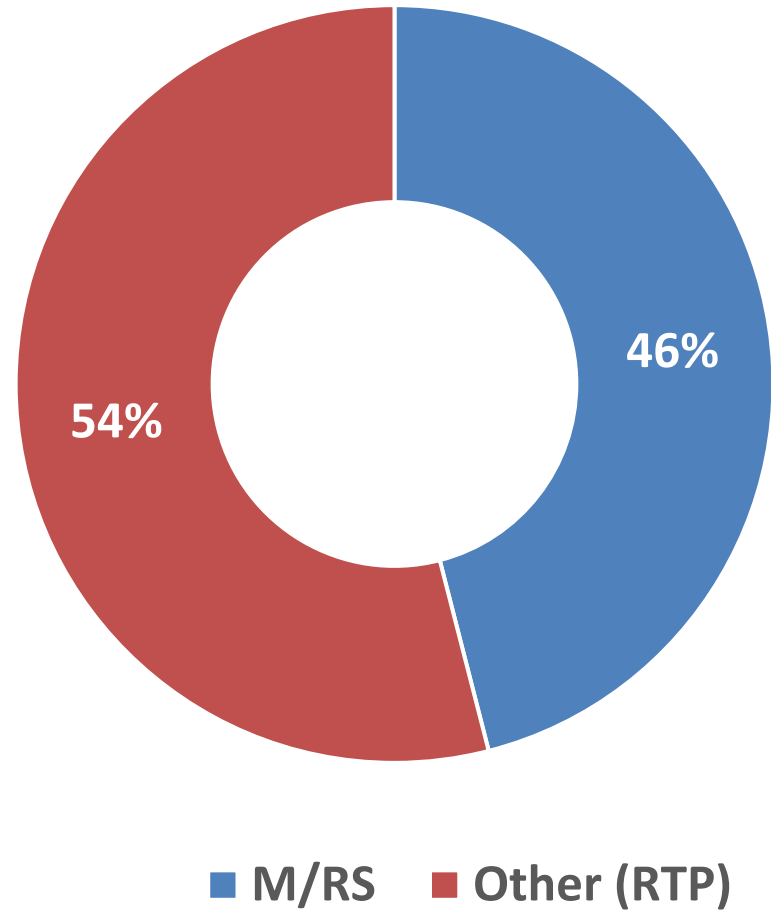

National Environmental Policy Act (NEPA)

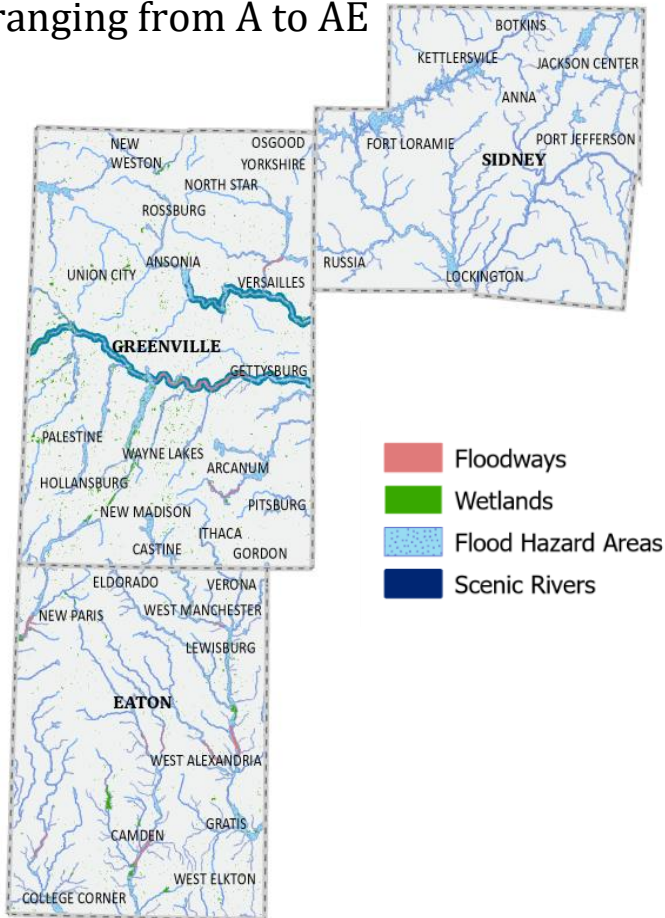
The National Environmental Policy Act (NEPA) process requires federally funded projects to account for possible current and future impacts to environmental resources within or surrounding the project area. Per the U.S. Department of Transportation (DOT), there are several categories for which impacts are analyzed:

- *Air Quality and Noise*
- *Community Impacts*
- *Cultural Resources*
- *Water Resources*
- *Ecological Resources*
- *Underserved Populations*
- *Asbestos*
- *Farmlands*
- *Floodplains*
- *Section 4(f) and 6(f) Resources*
- *Regulated Materials and Permits*
- *Public Involvement*

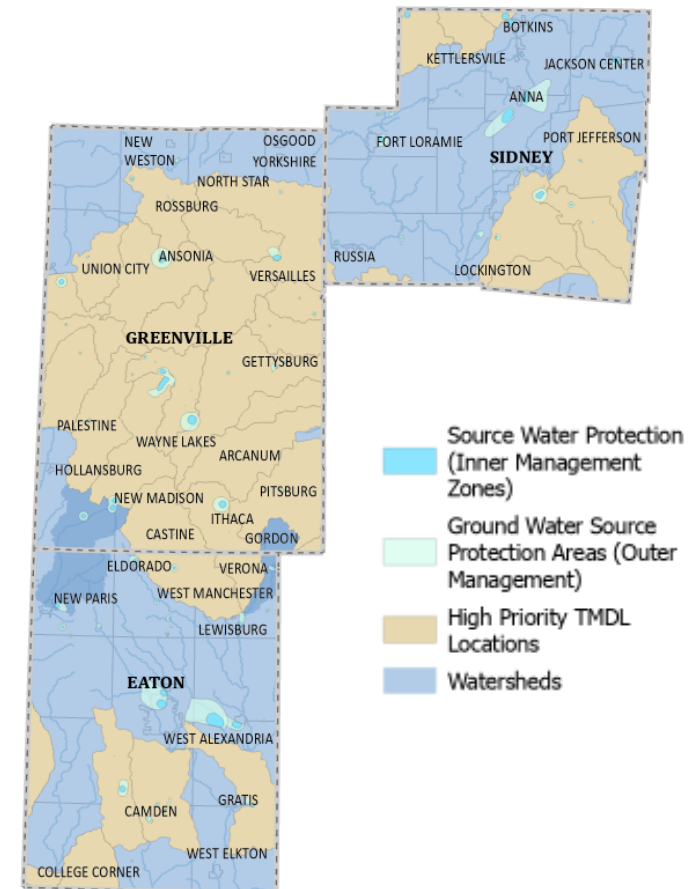
Wetlands and Floodplains

- a total of 7,000 acres of wetlands
- two scenic recreational Rivers
- a total of 35,000 acres of flood zones ranging from A to AE



Watersheds and Wellfields

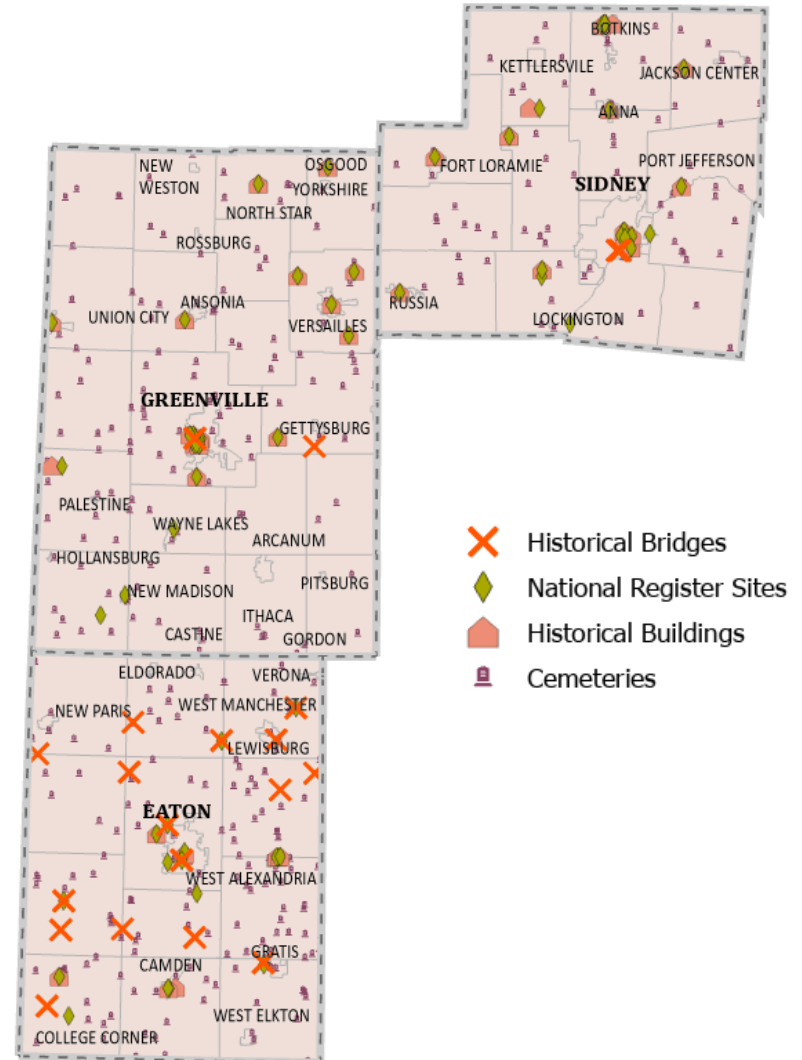
- 3,700 acres Wellfield Protection Areas
- 39 watershed areas with high priority TMDL



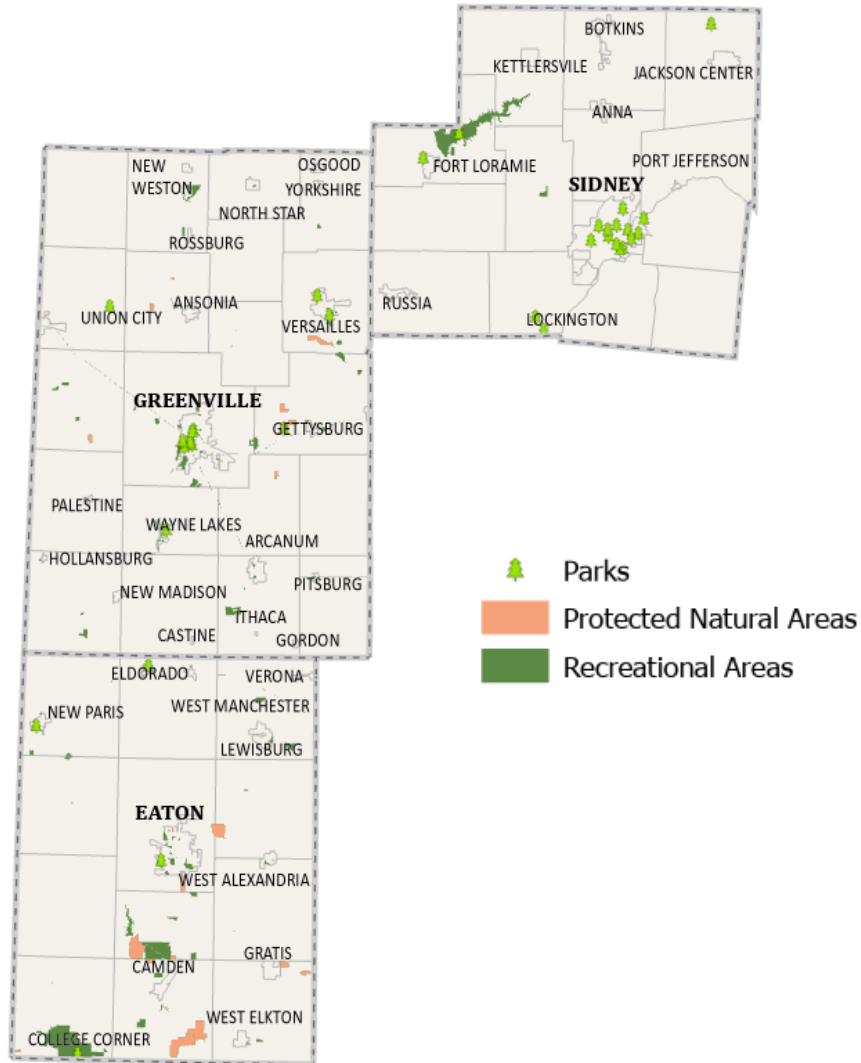
Inventory in the Region

Historic and Cultural Features

- a total of 21 historic bridges, with Preble County having the majority
- a total of 65 sites listed on the National Register of Historic Places, 47 of which are buildings of historical significance
- approximately 380+ cemeteries

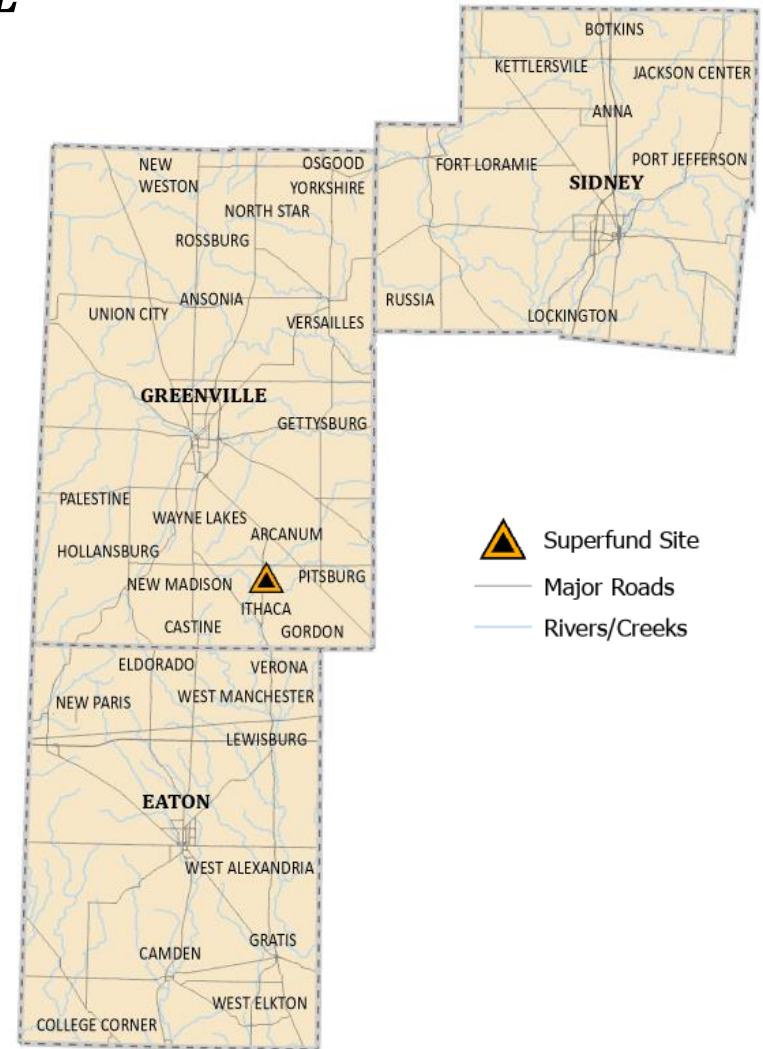
Parklands and Protected Areas

- at least 10 nature preserves, wildlife areas or sanctuaries, and a grand total of approximately 3,400 acres of protected natural areas
- a multitude of recreational areas, totaling at least 10,300 acres of land for recreational use

Inventory in the Region

Hazardous Materials, Superfund, and NPL

- one Superfund Site, located in Darke county, which was removed from the National Priorities List in 2001
- 4.5-acre Arcanum Iron & Metal 1960 – 1982; HRS: 62; Construction Complete
- Battery acid drained into a low area on site—reprocessing of the battery casings generated lead oxide sludge that collected on the ground surface
- EPA took the site off the Superfund program's National Priorities List (NPL) in 2001
