Comments



The following comments to the Final Draft Regional Active Transportation Plan were received by MVRPC. Responses to each comment are also provided here.

Date: July 13, 2022

From: Kathleen Shanahan

Comment: I am very disappointed there doesn't appear to be an attempt to make bikeway paths more equitable in the west and northwest parts of Montgomery County. Most of the resources seem to be focused on the south and eastern parts of our community, with the exception of a shared use path between Vickwood Lane and James H. McGee Blvd and a shared use path between Triangle Park and Rip Rap Road. Currently there is no safe way to bike downtown or connect to the majority of bikeways in our area if you live in the Northwest part of Montgomery County and this plan does not seem to address that. I'm not sure why there wasn't anyone representing any of the Northwest communities on the Steering Committee, although I will grant it is possible there wasn't any interest. As someone who has lived in the Northwest Montgomery County for a long time, this plan feels like continued disinvestment for our part of town.

Response: The commenter correctly points out the disinvestment in active transportation infrastructure on the west side of Montgomery County. This parallels other forms of disinvestment in western Montgomery County which roughly matches areas of federal government redlining from the 1930s and 1940's. It would be the hope of MVRPC that improved active transportation infrastructure would be a part of a broader plan for investment and development of western Montgomery County communities.

The draft Active Transportation Plan certainly prioritizes closing of trail gaps in the Wolf Creek Trail and the Stillwater River Trail, which will create connected bikeway corridors from the west and northwest to the Miami Valley Trails network. In addition, the draft specifically calls for improvements to, or construction of, sidewalks to serve transit routes in the northwest part of Montgomery County, where significant lengths of GDRTA routes are not served by sidewalk. In the more rural parts of Montgomery County, the draft plan adds a new proposed regional bicycle route connecting Brookville, New Lebanon, Farmersville and Germantown.

While no representatives of western Montgomery County jurisdictions were on the project steering committee, the panel does include representatives of agencies and organizations that serve western Montgomery County, including Greater Dayton RTA, Five Rivers MetroParks, City of Dayton, the National Federation for the Blind, Major Taylor Cycling Club of Dayton, and Bike Miami Valley.

The Dayton-Kettering MSA ranks 65th out of the 101 largest US metro areas for pedestrian fatalities. Between 2016-2020, 59 people were killed by drivers. We'd rather be lower and hopefully the Miami Valley Regional Planning Commission's Active Transportation Plan and other Dayton region road rebuilds will result in safer streets for all modes.

MVRPC shares the same goal that roads across the Region will be made safer and the deaths and serious injuries on our roads will steadily decrease. The inclusion of walking to what was previously strictly a biking plan will help raise awareness and attention to the needs of pedestrians in our transportation network.

Please consider changing the image on page 61 - this is a poor example of a "complete street" which does not feature transit in addition to pedestrians and cyclists. It appears to be a poor example of a cycle lane in general - one which NOT all cyclists (of all ages and abilities) would feel comfortable using. Consider using an image of a grade-separated cycle track or fully protected cycle lane next to a bus-rapid transit station - this seems to be more in line with the goals of the AT Plan overall.

Undergoing a Regional Active Transportation Plan is difficult, as stated in the plan, Active Transportation is inherently local. With that said, I am disappointed in the overall lack of community input and representation of the community. The vision statement for the plan is stated as "The Miami Valley's Active Transportation network provides safe and equitable walking, biking and transit connections which enhance access to opportunity, well-being, environmental benefits, and quality of life for all." The survey results informing the plan are far short of that intended vision. How can equity and access to opportunity be the intended outcome when the voices of the people are not heard? Based on the survey results, most respondents were middle age, white, and held an income greater than \$50,000. I am a City of Dayton resident and while I understand this is a regional plan, the input is lacking in even a representation of my city. Additionally, public input sessions held at libraries are not representative, nor are they sufficient to accurately capture the region as a whole, not to mention specific communities. To further this point, holding one session at a library in the City of Dayton and one session in the City of Springboro is not equitable community engagement, Dayton has 120,000 more residents! I believe that this plan falls far short as it relates to public input. Much more could have been done and should be done for the voice of the community to be heard in this plan.

A further example of this is the Web Input Map. Even if surveys in person were not where they should have been, in a culture that is highly interactive online, it would be a reasonable expectation that the web input map would be highly utilized, which is not the case. Again, as it relates to equity and access, the Web Input Map had 2 or 3 comments on the West side (south of James H. McGee), the very place where access and equity is most needed!

The recommendations for projects are fine and maybe the community would agree that the plan and recommendations are fine, but we do not know that until you have input from a full representation of the community. I understand that seeking community input is difficult, but when you are making a plan for the community, you endeavor to that difficult work. The plan adoption should be paused and a renewed effort to listen to the community should happen with equity and access in mind (as is the vision of the plan).

The Miami Valley Regional Planning Commission strives to improve our community engagement and public input processes on a continuing basis. We accept your critique of our engagement process for the draft Active Transportation Plan. However, rather than halt the

process of adoption of the draft and delay implementation, MVRPC would prefer to invest efforts in continuing engagement with under-represented communities, as part of a continuous process to implement and update this plan. An opportunity exists at this moment to hear the voices from the west side of Dayton as the City of Dayton is currently developing a local Active Transportation Plan for the city.

What is the feasibility of including a connection between Montgomery County project number 77 (741 bike lanes) to project 4 around the area of McEwen Rd and Congress Park Dr. in the plan? Such a connection might route from the proposed 741 bike lanes, through the Hunt Dr. /Newmark Dr. /Gander Creek Dr. area onto Lyons Rd where it would connect to project number 41 at Lyons Rd and Yankee St and continue towards the Lyons Rd and McEwen Rd intersection to then connect to project number 4.

I believe an additional connection could be made between the current termination of Mont project 41 at Yankee St and Lyons Rd and be extended along Yankee St to connect at project number 4 at Yankee Park.

These connections could help make easier access to the eastern side of the Dayton Mall from the southern, eastern, and northeastern approaches. They could not only improve access to the GDRTA South Transit Center for those approaching from the east, but they could also make for easy navigation around the mall area for recreation and for access to the many jobs in the mall area.

I would love to hear MVRPC's thoughts on these routes and the possibility of including them within the existing proposed projects.

The active transportation connections in this comment are well thought out. Completing sidewalk gaps along Lyons between SR 741 and McEwen Road and developing a bicycle facility would certainly improve access to the GDRTA hub and the Dayton Mall commercial area. The same suggestions along Yankee from Yankee Vineyards Drive to Yankee Park would create a dense network for active transportation. Creating a comfortable crossing of SR 725 and Interstate 675 would be a challenging engineering project, however.

From: Comments from Virtual Public Meeting

1. Thank you for adding these populations to your plan. It was important to MVRPC to ensure that the active transportation planning program have the needs of more than just bicyclists in mind as we implement our planning process. The inclusion of pedestrian considerations serves everyone, and includes people with disabilities.

2. How is proposed and existing bike infrastructure going to be improved to encourage more usage? A basic bike lane might not be conducive to all users. Are protected bike lanes and/or off-street bike paths going to be a major aspect within some of the proposed projects to help encourage bicycle users of all confidence levels? This draft Active Transportation Plan continues the emphasis we recognized in the 2015 Bike plan Update that cyclists prefer greater separation from motor traffic. Where possible, this plan makes recommendations for separated facilities over shared facilities for cyclists. Another benefit of separated facilities is that in many cases, such facilities can also serve pedestrians. An example would be a sidepath.

3. There is a core group of bicyclists and walkers that know of the trails and paths in the area. But there are also a great many people that seem to know nothing about it. I would like to see an educational component added to inform. MVRPC takes a leading role in the development of the regional bikeways maps and companion website, miamivalleytrails.org. In addition, opportunities to partner with organizations that promote the trails for transportation, tourism, economic development and health can be encouraged in the plan text.

4. I am excited for many of the projects within the draft. How far in the future will we expect to start seeing projects from the AT Plan being completed? Are all projects listed in the appendix of the final draft eventually going to seek funding, or will some proposed projects not be completed at all due to funding issues? Like all MVRPC transportation plans, the Active Transportation Plan is written as a twenty-year plan, with expected periodic updates. We would hope that many of these projects would come to fruition over that time, through the work of the local communities as project sponsors.

5. Thanks again for all the work! Nice to see something other than roads take center stage. MVRPC's commitment to safe, complete streets dates back to the adoption of our first bikeways plan in 2008 and the Regional Complete Streets Policy in 2011.

6. Thank you Matt & Team for your work on this project. It presents an ambitious set of goals for our region and I look forward to working with MVRPC and our regional partners to complete. Working closely with local government across the region will be the key to continuous development of active transportation networks in the Miami Valley.

7. Will the Region be looking at a Vision Zero Plan in order to access additional federal funding programs? MVRPC is aware of the Safe Streets for All program (SS4A) which requires a systemic safety action plan in order to qualify for project construction funding.

MVRPC is currently studying if this draft plan and other safety analyses might collectively qualify as a systemic safety action plan. If so, then MVRPC or our members covered by those documents may be eligible applicants for project funding. If not, MVRPC can determine what missing pieces would need to be developed to meet that standard. To date, no discussion has been held to develop a Miami Valley Vision Zero Plan, however, MVRPC has adopted for our Region the State of Ohio's goals for an annual two percent reduction in five measures (number of fatalities, number of serious injuries, fatality rate, serious injury rate, and number of non-motorized fatalities & serious injuries).

8. How does this plan connect with local plans developed by municipalities in the Region? The development of the draft Active Transportation Plan included a thorough review of local plans, including local bike and pedestrian plans, safe routes to school plans, thoroughfare plans, trails plans and corridor or comprehensive plans. The projects listed in those plans that were not yet completed were reviewed for inclusion in this regional plan.

9. Can you discuss your engagement strategy? MVRPC held a series of public input meetings at public libraries throughout the Region. The meetings included survey opportunities and a mapping exercise. An online version of the meeting activities was available as well. We also met with focus groups of transit users, and a group of sight impaired residents organized by the Miami Valley Chapter of the National Federation for the Blind.

The public notice strategy included an extensive array of online and print advertisements of the meetings and for the two comment periods. These are presented in great detail in the Public Involvement Summary.
